Notwithstanding the foregoing all parts and goods are at the risk of the customer from the time of supply.
4. Every care is taken to ensure that products supplied by the company are in good and usable condition. No claim to the contrary will be entertained unless in writing by the customer within seven (7) days of delivery to the customer.
5. The limit of any claim against the company shall be at the price for the price for the product/s the cause of such claim and in particular no claim for consequential loss will be recoverable against the company.
